

- Form F - for claims by any other stakeholder

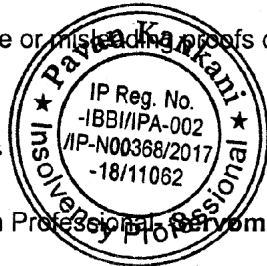
